

Recruitment of Retired Technological Service (Civil) Officers on Contract Basis for the Additional Staff Required to Restore the Damages Caused within the Central Province due to the Ditwah Disaster Situation – 2026

Applications are hereby invited from the retired officers of the Technical Service (Civil) Special Grade or Grade 1 posts, in accordance with the provisions of Public Administration Circular No. 03/2018 and Public Service Commission's Circular No. 03/2019, for recruitment of temporary staff required to restore the damages caused to the physical resources maintained by the institutions under the Central Provincial Council due to the Ditwah disaster situation

The closing date of the application is 22.06.2026.

01. General Qualifications

- 1.1 Applicant must have retired from a position in the Special Grade or Grade 1 of the Technological Service (Civil).
- 1.2 Retired applicant's age should not be more than 65 years as of 31.12.2026.
- 1.3 Applicant should possess the adequate physical and mental fitness required to serve in any area of Central Province and discharge duties of the post
- 1.4 Applicants residing any part of the Island shall apply.

02. Conditions of Recruitment:

- 2.1 This recruitment will be made on a contractual basis in accordance with the provisions of Public Administration Circular No. 03/2018 on re-employment of retired public officers and as per Public Service Commission's Circular No. 03/2019.
- 2.2 It does not mean that that all retired officers applying for this will be recruited on a contract basis.
- 2.3 Recruitment will be made for a period up to 31.12.2026, and this period may be extended depending on the service requirement.

03. Documents to be Submitted

- 3.1 Curriculum Vitae of the applicant.
- 3.2 EST – 09 form, as indicated in Annexure 01 hereof
- 3.3 The recommendation form for re-employment of a retired officer as specified in Public Administration Circular 03/2018 (indicated here as Annexure 02), must be submitted with the recommendations of the Heads of the Institutions (Ministry's Secretary / Head of Department / Head of Institution) where the officer served at the time of retirement.
- 3.4 Original copy of Birth Certificate.
- 3.5 Certified copy of the National Identity Card (NIC).
- 3.6 Original copy of Medical Certificate obtained from a Government Medical Officer (Annexure-03) confirming that the retired officer to be re-employed possesses the physical and mental fitness to serve in the respective post.
- 3.7 Certified copy of the Retirement Letter.

04. Salary

4.1 Payment will be made in terms of the P.A. Circular No. 03/2018 on re-employment of retired public officers.

05. Duly perfected applications should be posted under registered cover, to reach “Secretary, Central Provincial Public Service Commission, No. 244, Katugastota Road, Kandy” on or before 22.06.2026. The caption of “Recruitment of Retired Technological Service (Civil) Officers on Contract Basis for the Additional Staff Required to Restore the Damages Caused within the Central Province due to the Ditwah Disaster Situation – 2026” should be indicated on the top left hand corner of the envelope enclosing the application. Applications received after the closing date of applications, incomplete application from candidates who do not possess the general qualifications mentioned in the notification will be rejected without any notice. No complaint will be entertained in relation to the loss of applications or documents in post or delays in delivery.
06. The Central Province Public Service Commission reserves the right to make decisions regarding any matter covered or not covered by this notification, as well as the final decision regarding the number of personnel to be appointed on a contract basis. Furthermore, if there is any matter for which provisions have not been made in this notification, the power to clarify and make a decision on such matters rests with the Central Province Public Service Commission.
07. In the event of any inconsistency between the Sinhala, Tamil and English text of this notification, the Sinhala text shall prevail as the accurate text.
